Introduction

The findings of a recent study showed that there is a significant benefit to students who participate in out-of-school-time (OST) programs. In fact, the <u>Return on Investment of Afterschool Programs in Pennsylvania</u> study determined that for every dollar invested in after- school programming for students there was a return of \$6.69 in potential benefits to students, including reduced rates for drop-outs, teen pregnancy, substance abuse, crime and delinquency (Link to PSAYDN.org).

In accordance with the American Rescue Plan (ARP) Act and Pennsylvania Act 24 of 2021 (Act 24), the Pennsylvania Department of Education (PDE) will award approximately \$50,000,000 or one percent (1%) of Pennsylvania's ARP Elementary and Secondary School Education Relief (ESSER) State Reserve funds to support school districts, charter schools and cyber charter schools (collectively, LEAs) in the development and implementation of comprehensive after-school programs to address learning loss in response to the academic, social, emotional and mental health needs of students and subgroups of students impacted by COVID-19 public health emergency that supplement school programs and activities.

Act 24 requires that, when available, existing personnel shall be utilized by school districts, charter schools and cyber charter schools to staff programs and activities established with these grant funds.

Within 90 days of receipt of these allocations, school districts, charter schools and cyber charter schools must submit a three- part plan to PDE, that outlines the proposed use of the grant money, itemized by program and activity. This plan is part of a consolidated application that includes after-school programming, summer programming, and a comprehensive plan to address learning loss. The plan shall include:

- 1) A description of each program and activity
- 2) A narrative outlining the expected benefit of each program and activity
- 3) A budget for each program and activity detailing personnel and operating costs

Since 2006, Union School District has support a Homework Helpers Program to provide additional learning support for students who are struggling academically through afterschool support. The program is small and has only been able to staff one or two teachers on a limited basis throughout the year. Since the start of the Covid Pandemic, we have struggled to staff the program and the number of students needing support has increased significantly. Our district wishes to expand the program by hiring additional teachers and staffing the program four days per week so that the additional students will receive services. Throughout the 2021-2022 school year, our director of special education has worked with building administration and staff to build an early warning system in identifying students for our MTSS program. Using that system, we are able to identify students who are struggling and/or were significantly impacted by the pandemic academically. Those students will be enrolled in the Homework Helpers program with the goal of building the students' skills through additional instruction and practice. Factors included in the early warning system include attendance data, disciplinary data, course grades, and assessment data.

In developing an early warning system which takes into account the students' disciplinary record, attendance, classroom academic performance, and benchmark assessment performance, the district will identify and recommend students who would qualify/benefit from services. Through continuous periodic monitoring of the EWS, students will be recommended to either enter or exit the program.

As the district continues to review, revise, and align curriculum to the PA Core Standards, students will focus on skill building activities and lessons through the Homework Helpers Program. Utilizing classroom resources, lessons, work assignments, and supplemental materials, instructors will reteach and reinforce the core skills that students require to be successful in the core content areas. Students who lack the support structures at home and
