### UNION SCHOOL DISTRICT Administrative Reports September 21, 2023

### I. School Police Officers

### SPO Report for September 2023 Board Meeting

### **Significant Incidents**

PSP was contacted to investigate an incident after a highschool student dumped a carton of milk on another student during lunch. The student suspect is a habitual offender and will be cited by PSP.

Video was reviewed after a student reported he found all the sink faucets turned on in the upstairs boys bathroom. A suspect was identified and an admission obtained by the Principal who also issued the discipline.

SPOs assisted PSP with two missing persons cases on the same day, one was a UHS student while the other was a Redbank student. The two cases were linked. The female student from Union was believed to be with the male student from Redbank. Both students have since returned home. NOTE: The missing student from Union was also the same subject of the first paragraph.

Clint Lineman was observed on school property at the varsity football game. He was escorted off the property without incident. He was again warned he is not permitted on school property.

### **VAPE Incidents**

Two vapes were confiscated on the 1st day of school. Discipline issued by the Principal.

### **Threat Assessment**

The High School Threat Assessment Team convened for one threat assessment during this time period. The threat was deemed transient.

The Elementary Threat Assessment Team has handled three threat assessments during this time period. All three were deemed transient.



Healthy Alternatives for Little Ones (HALO) is an evidence-based program that encourages healthy eating, exercise, emotion recognition, and educates children about the harmful effects of alcohol, tobacco, and other drugs (ATOD) on the body. HALO provides age-appropriate learning opportunities for children through fun, hands-on activities that involve educational songs, videos, group activities, and books.

Suggested Schedule: 8 classroom sessions

Grades: Pre-K - 1st grades



I Can Problem Solve is an evidence-based program that helps children learn about perspectives, solutions, and consequences of their actions. The idea behind this curriculum is to teach how to think instead of what to think.

Suggested Schedule: 5 classroom sessions

Grades: Pre-K- 6th grades



Too Good for Drugs (TGFD) is an evidence-based program to promote healthy decision-making and positive healthy youth development. TGFD teaches students about goal setting, decision-making, bonding with others, identifying and managing emotions, and communicating effectively. In addition, the curriculum includes information about the harmful effects of the use of alcohol, tobacco, and other drugs on students' bodies and minds. The curriculum is engaging and educational, utilizing hands-on activities, such as, group work, games, and role-playing activities. Too Good for Drugs program correlates with the Pennsylvania Health Education Content Standards.

Suggested Schedule: 10 classroom sessions

**Grades:** Kindergarten-6<sup>th</sup> grades
